



## **ST ANDREWS HARBOUR 50:50 CLUB**

- The Lottery shall be known as "The St Andrews Harbour 50:50 Club" and administered by St Andrews Harbour Trust (StAHT).
- Anyone aged 16 (sixteen) years and over may participate in the lottery.
- As the name "50:50 Club" suggests, 50% (fifty percent) of the gross receipts of sales of tickets for each month will be retained by StAHT and the remaining 50% (fifty percent) will be distributed in prizes.
- Monies retained by StAHT will be used for the maintenance and improvement of St Andrews Harbour.
- The amount of money in the prize fund will depend on the quantity of tickets purchased by members.
- Payments must be made in advance and are non-refundable. StAHT accepts no responsibility for non-received or late payments.
- Each ticket purchased by a member will cost £10 (ten pounds) per year or as may be determined from time to time by the StAHT Board of Trustees.
- Membership will be for a period of one year (January to December draws) and is renewable annually.
- Actual tickets will not be issued. A unique number will be allocated to each ticket and the number(s) announced to members before their first draw.
- Members will retain these same number(s) for each month's draw.
- No prize money from the lottery shall be paid to any person other than the person to whom the winning ticket number was sold.
- There will be a draw for prizes each month, commencing in January each year. All draws will take place in the presence of at least two StAHT Trustees and a member of the public. The member of the public will be required to place their signature against the winning numbers for each draw made.
- Two prizes will be awarded each month: Excepting December, a First prize will be 64% (sixty four percent) and a Second prize will be 32% (thirty two percent) of the available prize fund for that month. The remaining 4% (four percent) of the available prize fund each month, excepting December, will be retained and allocated to the bonus prize fund for the December draw. In December, a First prize will be 67% (sixty seven percent) and a Second prize will be 33% (thirty three percent) of the available prize fund for that month, including the bonus prize fund.
- The prize winning numbers will be posted on the StAHT Facebook page.
- All prize monies will be paid out by cheque.
- Where the rules are silent or in cases of ambiguity or dispute, the decision of the StAHT Board will apply.
