List of [English] parishes and dissenting meetings which contributed nothing towards the brief for repairing the harbour, 1731; rousps of shore dues; estimates for repairs; petitions from skippers etc; contracts with tradesmen; reports by engineers; ABC of shore dues, 1811; certificates of brigantine "Romulus" of Arbroath, 1815, of sloop "Janet" of Arbroath, 1819, and of the "Eliza and Ann" of Montrose, 1820; parliamentary returns of harbour dues, 1844-46; harbour lights poster, 1849; barometer for fishermen, 1859. 3/B/4

Box 63 St Andrews harbour miscellaneous documents, 1870 - 1897. Similar In content to box 62. Contracts for repairs, 1876; application for post of harbourmaster, 1881; St Andrews harbour provisional order, 1897, and correspondence relating thereto. 3/B/4

Pringle and John Thomson v magistrates, 1840-41; burgh v James Ritchie, 1877-78; burgh v David Edie, 1878-80.

Box 65 St Andrews harbour, vouchers for accounts, 1750 - 1874. 3/B/5

Box 66 Lighting, 1821 - 1881. Mostly vouchers for street lighting and work connected therewith (early lights used whale oil); lamp posts, 1835-36; new subscription for street lights, 1831. 3/B/5

Box 67 Priory Acres, 1606 - 1759. Miscellaneous titles and a few other papers relating to the Priory Acres. 3/B/5

Box 68 Vouchers for refreshments paid for by town council c.1725 -1825, eg at elections, King's birthday celebrations, admission of burgesses, apprising of common mills, fixing of town fiars, rousing of dung, setting March stones, signing dispositions and other public occasions, ranging from drinks to elaborate dinners. 3/B/5
